

**SUMMARY ANNUAL REPORT  
FOR  
United Mine Workers of America 1993 Benefit Plan**

This is a summary of the annual report of the United Mine Workers of America 1993 Benefit Plan, EIN 52-1888497, Plan No. 501, for period January 01, 2011 through December 31, 2011. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$4,163,427 as of December 31, 2011, compared to \$4,539,513 as of January 01, 2011. During the plan year the plan experienced a decrease in its net assets of \$376,086. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$54,516,885, including employer contributions of \$8,239,807, participant contributions of \$28,874, earnings from investments of \$54,663, and other income of \$46,193,541.

Plan expenses were \$54,892,971. These expenses included \$8,099,779 in administrative expenses, and \$46,793,192 in benefits paid to participants and beneficiaries.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

Suite 350, Washington, DC 20037-1879) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
